

In light of the growing climate emergency narrative and the critical need for it be accompanied by concrete action, The Club of Rome convened a high-level Roundtable at Chatham House, entitled "Emerging from Emergency: urgency as a catalyst for action and regeneration", as part of the inaugural London Climate Action Week.

The event brought together change-agents from across the broad spectrum of the climate emergency and sustainability space, from prominent youth activists and business leaders, to city-level decision-makers and policy experts. The meeting was an unprecedented opportunity to build a network of actors and to catalyse action-oriented responses to the climate emergency, by deliberating on and co-designing a set of key solutions to bring about the immediate shifts and longer-term transformational changes which are so desperately needed. The Roundtable laid the foundations for a concerted and solutions-oriented response to the climate emergency, by building a coalition of actors and agreeing on key principles and next steps.

On 5th and 6th November, The Club of Rome held its first Annual Conference in sub-Saharan Africa. The event marked a milestone in the Club's history, as it sought to reconnect with the "Mother Continent" and broaden its reach beyond its traditional European heartlands, channeling the spirit of ubuntu and opening its perspectives to the voices of younger generations.

Members and delegates – entrepreneurs, sustainability professionals, academics and policy experts from across the African continent and beyond - gathered at Spier estate in the winelands of Stellenbosch, near Cape Town, for two days of enriching and engaging discussions. These revolved around the four guiding themes of the Club's work: Climate-Planetary Emergency; Reclaiming and Reframing Economics; Rethinking Finance and Emerging New Civilisation.

The voices of younger generations were brought

to the fore through the Club's very first Youth Summit, held in parallel to the AGM. Young entrepreneurs, thought-leaders and policy experts gathered to debate and share novel, progressive perspectives on the guiding themes of the Club's work. These were then infused into the public CoR Summit on the following day, where selected youth delegates joined panelists for lively and open dialogues on the topics at hand.



The rich discussions, combined with the numerous partnerships fostered by the Summit, provided the Club with novel contexts and insights with which to implement its guiding vision of operating as a Platform of a rich diversity of Thought leaders and Activists able to collaborate in the promotion of our agreed thematic program.

The Club's work will continue to be implemented through its Impact Hubs which will bring together members, policy makers, private sector actors, scientists, civil society activists, and young leaders. We are committed to broadening the scope of our work and network to the African continent. This ambition will, amongst others, be carried forward by a new regional CoR Hub in Africa, through which thought leaders, change-agents and youth from across Africa will be able to co-create tailored solutions within their local contexts. We will redouble our efforts to promote intergenerational conversations that will build on the Cape Town Youth Summit, as well as weaving in the engagements with young people in Europe and across the globe.

The Planetary Emergency Plan

In September 2019, The Club of Rome launched The Planetary Emergency Plan on the sidelines of the UN Climate Action Summit in New York. The Plan, which was drafted in partnership with the Potsdam Institute for Climate Impact Research (PIK), provides a set of key policy levers addressing the cross-cutting challenges of climate change, biodiversity loss and human health and well-being. It outlines a vision of transformation and regeneration, a roadmap for governments to set in motion a decade in which the development path of our planet is steered onto one which is inherently beneficial for all living species, leaving no one behind.

Its framing is simple yet compelling - a catalytic intervention designed to spur emergency action at the highest levels of decision-making. It is a novel contribution to the emergency debate, recognising the inextricable interconnectedness of the three challenges referred to above and providing an alternative approach to conventional siloed policy action. Concretely, it combines a focus on protecting and restoring our Global Commons with implementing a series of economic and social transformations to guarantee the long-term health and well-being of people and planet.

The Plan was launched in the presence of a number of Heads of State and Government (Austria, Bhutan, Central African Republic, Costa Rica, Fiji, Monaco, Norway, Seychelles, UK) as well as First Vice-President of the European Commission for the European Green Deal, Frans Timmermans. The presentation of the Plan was part of an overall strategy to secure high-level commitments to a New Deal for People, Nature and Climate in 2020. This would be underpinned by the adoption of a Planetary Emergency Declaration and concomitant Action Plan in the course of 2020, considered a "super year", with critical high-level political decisions due on climate, nature and sustainable development.

The combination of the launch with another supporting event in New York (the Nature4Climate Hub), enabled the Planetary Emergency Plan to be infused into international discussions on climate, biodiversity and sustainable development, providing The Club of Rome with unprecedented entry-points at the highest levels of decision-making. This was particularly exemplified by an invitation extended to The Club of Rome by First Vice-President Timmermans' cabinet to meet in Brussels and jointly explore how the Planetary Emergency Plan could be a guide for crafting the new European Commission's flagship policy proposal, the European Green Deal (EGD).

The Club also held a series of advisory meetings with the cabinet of the President of the European Commission, Ursula von der Leyen. Leveraging its network of thought leaders and practitioners, the Club distilled a wealth of knowledge, insight and policy

proposals into an open letter and policy paper addressed to the cabinet, in view of the publication of a broad-strokes communication on the EGD on 11th December 2019. The document was based on the ten-year action framework outlined in the Planetary Emergency Plan, and makes concretes calls for transformative action from 2020 onwards, while also calling for the longer-term systemic shifts needed to truly emerge from the planetary emergency.

The Plan will be a defining pillar of the Club's work throughout the "super year" of 2020, as it seeks to secure the scale of emergency action required, at the highest levels of decision-making.

The statement was posted on the Club's website and social media channels, and sent to leaders of the European Council, Commission, Parliament and EU Member State governments..

Statement in Support of Global Student Climate Protests Winterthur, Switzerland, 14th March 2019

People always tell me that they are so hopeful that young people are going to save the world. But they are not. There is simply not enough time to wait for us to grow up and become the ones in charge.

This week, hundreds of thousands of students in multiple cities across the globe will once again follow in the brave footsteps of Greta Thunberg by staging climate demonstrations. Their call to world leaders is simple yet true: "it is time for less talk and more action on the climate".

We deem the students' concerns to be utterly justified and irrefutable and will continue to play our role in ensuring ambitious climate action. These courageous young leaders point to challenges for the planet and humanity which have long been recognized by the scientists, economists, business leaders and experts within the Club of Rome.

It has been 50 years since the "The Limits to Growth", which alerted the world to the acute environmental and demographic challenges ahead. Decades of exponential growth in both population and consumption are now colliding with the limits of the Earth's biosphere. We concur with the Extinction Rebellion and the student protesters that we cannot turn a blind eye to the dual tipping points of species extinction and climate change. Emergency action is more necessary than ever and cannot be put off any longer. We no longer have the luxury of time!

We know the facts. We have the solutions. We just need the political will. Global action is lagging and is often woefully inadequate, stymied by political meandering. This is why we are calling on governments across the world to listen to the call for urgent action from young people, scientists and experts and translate these calls into concrete Climate Emergency Plans with clear targets and time lines. To avoid the worst outcomes, global carbon emissions must be cut by half by 2030 and to zero by 2050. For the wealthier nations, this increases to around 80% by 2030, with full de-carbonisation less than a decade later. This is an unprecedented task, requiring a reduction rate of at least 7% annually; no country has to date achieved more than 1.5%.

The only possible response is emergency action that will transform human social, economic and financial systems. Yet we also believe that the existential threat from climate change, if heeded now, offers the possibility for a societal renaissance of unprecedented proportions. This is the vision we seek to promote - a vision of the future, which ensures well-being for the many and harmony between humanity and the planetary boundaries that protect us. A vision which speaks to the calls from young people marching on the streets in towns and cities across the world.

Engaged citizens of all ages demanding action by their politicians on climate change is of paramount importance, to hold us all accountable for delivering on our climate goals and ensuring that we seize this opportunity to sustainably transform our economies.

Let us find the vision, the leadership and the creativity to collaborate in developing constructive solutions for a decent future for present and succeeding generations. We have the capabilities: we must now find the will and listen to the enlightened youth who have taken time away from their studies to march on the streets to be heard.

Climate-Planetary Emergency



Climate change and Biodiversity loss are two of today's most pressing global challenges, constituting an existential threat to humanity. Planning for planetary emergency is a pragmatic response to a known risk and humanity's insurance plan for survival and a positive future. The Limits to Growth alerted the world to the environmental and demographic challenges. The central message was that the quest for unlimited growth in population, material goods and resources, on a finite planet, would eventually result in the collapse of its

economic and environmental systems. That prediction is clearly manifesting in the climate change crisis we are confronted with today. Our historic recognition of the existential nature of this threat, the need for an emergency response, and the opportunity that such planning can present, is the unique contribution which the Club of Rome wishes to bring to the global community. We are calling on governments, business leaders, the science community, NGOs and citizens to rise to the challenge of responding to planetary emergency, so that our species can survive and create thriving civilizations in harmony with planetary boundaries. Acknowledgement of these challenges and opportunities creates the basis for a societal renaissance of unprecedented proportions. This requires swift action and the collective implementation of one of the most comprehensive emergency plans ever contemplated. The Club of Rome believes that such action, difficult as it may be, will create a much healthier, happier, safer and innovative global society.




A new civilization cannot be advanced by an economic system that has produced much of the current malaise. The metrics applied to human and planetary progress must focus on well-being, extending innovatively beyond

GDP to reflect the true cost, risk and opportunity of human pursuits. The Club of Rome will continue to push for the exploration of a new set of values and principles. The shift from mainstream economics and policy-making based on fundamentally flawed economic theory and indicators promoting a growthcentric philosophy rather than the well-being of people and the planet, is necessary to ensure a reversal of crucial ecosystem, climate and social tipping points. Economics that reflect a New Civilization must go deeper in its cosmology than GDP growth. It must give greater attention to the institutional challenges presented by the need to free humans from servitude to financiers and growth indicators while restoring the health of Earth's regenerative systems and meeting the essential material, social, and spiritual needs of all people.

Rethinking Finance



The global financial system is currently at the service of an outdated economic paradigm. It acts as a means of wealth accumulation for a narrow elite, whilst disregarding the negative externalities of environmental damage and social inequalities. A new, sustainable finance system will be a core pillar of a new economy which serves both humanity and the planet. The monetisation of all transactions will need to be re-visited to enhance the equitable distribution of wealth and ensure broader well-being of all peoples. This means putting conscious effort and science into moving away from finance as a value system benefiting the few, to accelerating a move toward real economy wealth creation for the many.



A new paradigm is essential to clarify our role as a species within the greater Earth Community. Conversations are needed to agree on core values that promote human dignity, respect for nature and protection of the commons beyond current generations. These would be foundations of a stewardship culture for all we do as a human race. The Club of Rome is repositioning itself to challenge humanity to rise to its full potential and become good stewards of the Earth's limited resources. Our call is anchored in the need for a paradigm shift in our fundamental belief matrix, and the complex economic, financial, social systems underpinning our daily interactions. We are determined to identify and mobilize those already engaged in the quest for a New Civilization to become part of a Network of Networks to pursue this vision.

Club of Rome Youth

It is becoming ever clearer that greater intergenerational dialogue and understanding is needed to address some of the most pressing issues facing humanity today. The global student strikes for the climate demonstrates that younger generations are increasingly mobilised and engaged. Many want the same systems change dynamics as the members of the Club of Rome and fundamental shifts in our current economic, political, and social systems. 
